

To whom it may concern.

We wish to submit an objection to the present plans for the following reasons -

Our property will now be closer to the main road & footpath & liable to further onslaught of foreign missiles such as beer bottles, beer cans, broken glasss etc etc being dumped in our drive putting our vehicles liable to even further damage.

To protect our home & vehicles it will be necessary to have gates 2 metres high, fitted and fence fitted to perimeter walls.

A more serious problem will occur when we leave our property by car & will have to park our car on bus/cycle lane, turn off engine, lock car & return to close our gates THINK ABOUT THAT FOR A MINUTE, ABSOLUTE CHAOS.
