



We are writing to An Bord Pleanala to urge you to reject the proposal by the NTA to CPO a recreational field used extensively by a local community.

The field in question between 45 and 47 Ayrfield Drive is a green space enjoyed by residents, young and old, and their pets.

Children play in that field for hours, daily. The proposal to open up the space to a busy dual carriageway is essentially removing its status as an area for recreational use.

Instead, this unwanted access will generate anti-social behaviour and create a 'rat-run'.

Ayrfield is a low crime estate with safe, secure streets and has been for many years.

The NTA believe they are doing the Ayrfield community a favour, they have stated so in their documentation :

"A new offline footway and two-way cycle track is proposed at Ayrefield Drive. This will require land take to facilitate the proposal and provides an excellent opportunity for local residents to avail of direct connectivity to the corridor with a proposed new bus stop also located in the immediate vicinity" Reference : [Preliminary Design Report](#)

The reality is that the NTA failed to investigate if the proposal would be 'an excellent opportunity'

- They never contacted a single member of the community with this detail

5. Grounds

- They didn't even bother to make contact with houses directly adjacent to the field in question
- In fact on review, the proposal was an extremely small detail in their original submission – and arrow with text stating “POTENTIAL NEW PEDESTRIAN ACCESS TO AYRFIELD ESTATE” and no colouration to show the proposal on an extremely large scale plan.



- The public consultation process when the proposal started to detail out the Ayrfield Drive ingress was carried out during a national emergency (Covid) – when most people were fearful to leave their house and were certainly not going to the shops to review the national press.

So – since the NTA never bothered to engage directly with the community we as a committee decided to ask residents how they felt about it.

Attached directly below is zip file containing a door to door petition of the Ayrfield / Ard Na Greine community.

5. Grounds

The summary is that of all residents who were available and reviewed the petition, there was 97% opposition to this CPO proposal.

The petition contains signatures from 619 households - this is a loud and clear statement of opposition from our community.

The community also united for three residents meetings so far. These have been attended in very large numbers. The community is clear in its conviction to object to this proposal.


Other observations that were collated from our community during the door to door petition included :

- Ease with which criminals could abscond from Gardai after perpetrating criminal activity.
- We will see an increase in statistics for crime in what is currently a low crime area. Including but not limited to burglaries and muggings.
- A number of residents indicated that they take evening walks and stay within our estate for safety reason – that security will be removed if this CPO proposal is approved
- Child safety concerns in relation to the ease at which a child could be abducted through the opening
- The children of Ayrfield Drive live in a Cul-de-sac in one direction and a de-facto cul-de-sac in the other (as there is no reason for through traffic down to Newtown Drive) – our children are now acclimatised to a safe, secure play area. We allow our kids to play outdoor with our front doors open, like many of us adults recall doing growing up in the 70s and 80s. We are lucky to feel this security in our estate. That

security will be gone once you open up access to a busy dual carriageway. Our children will lose that freedom to enjoy their road – and obviously will lose their main field of play.

- We feel that with this opening to such a busy dual carriageway it is only a matter of time before there is a catastrophic accident – most likely involving a child.
- The loss of a community amenity that is used daily for children playing and dog exercising. The field has also been used to host outdoor birthday parties (particularly during Covid times)



- There were concerns raised about the obvious increase in noise pollution once the separating wall is removed.
- The direct roads around the field will now be used for parking for access to the dual carriageway and related bus stops. This will affect local resident's access, emergency service access and also generally increase the volume of traffic into a quiet, safe estate.

5. Grounds

We, as members of this committee, urge An Bord Pleanala to see the wishes of the massive majority of Ayrfield residents and with that in mind reject to CPO proposal for our local community green space (between 45 and 47 Ayrfield Drive).

Dear Residents,

The National Transport Authority (NTA) are requesting planning permission to open the green space on Ayrfield Drive (between 45 and 47) to provide access to the Malahide Road dual carriageway. This is part of The Clongriffin to City Centre Core Bus Corridor Scheme (The Proposed Scheme).

According to the NTA, the aim of the Proposed Scheme is to provide "safe, sustainable transport movement along the corridor". The residents on the Drive that have been canvassed think this proposal is anything but safe for our community.

The potential concerns on the entire estate include:

- Overall safety of the area
- Increase in anti-social behaviour
- Children losing a popular green space
- Direct access to dual carriageway for children who are used to playing outdoors in a safe, secure residential area. The child safety implication here is huge for the area.
- Strong probability of change in our low crime area to an area of high crime as it is easier to abscond from Gardai
- Increase in vehicle parking for people wanting to use the bus connect service
- Increase in vehicles driving in the estate
- Unwanted direct access to dual
- Noise pollution from a busy dual carriageway

We will hold a further residents meeting in the coming weeks to explain the process of lodging objections. We have until 5.30pm on 2nd June 2022 to lodge our observations.

We are also holding a stand up meeting on the green in question on Saturday, 30th April @ 2pm. We have invited local TDs and Councillors to this meeting. We would appreciate your attendance to show the strength of feeling in the Community.






