

Reason/ Arguments.

 Child Safety. As a parent of 2 young children, the removal of the existing wall will now lead onto a dual carriageway. (Do not know any other area/ estate that has direct access to a dual carriageway) This is a major concern for my children's safety. There would be no barriers for my children, who are currently used to playing in an enclosed space, to unknowingly follow/chase a football from the green area straight out onto the dual carriageway.

- 2. Parking. With the new bus stop located on the dual carriageway there will be an increase in on street parking close to the site, which will bring its own and obvious dangers to residents. With an increase in parking, this will also affect local access for Emergency services i.e., Fire Engines and Ambulances, which will ultimately put people's lives at risk.
- 3. Crime. This is a low crime residential area, as there is only one way in and out. With the removal of this wall, there will be an extra entry and exit point for criminals by either bicycle/motor bicycle and or foot.
- 4. Anti-Social Behaviour. The easy access to a quiet and established residential area would undoubtedly bring an increase in pedestrian individuals on foot or motorised ones i.e., youths on motorbikes/scramblers, who are trying to abscond from the local gardai. With the proposed opening there could be a "Racetrack/ Circuit" man made for A.S.B individuals, starting at the Darndale Roundabout. Through the opening on Ayrfield Drive, onto Ayrfield Rd. Out onto the Tonlegee Rd left onto Millbrook Rd continuing straight onto Blunden Drive and back to the starting point of the Darndale Roundabout.
- 5. Green Space. This green space is a communal space used by the residents of Ayrfield Drive and one which connects both "ends of the road". The removal of this space would be detrimental in the community spirit and cause a divide in an otherwise tight knit community that has been built up by residents since the estate was established in the 1970's as our children would no longer have a space to play, host neighbourhood parties and bond together.
- 6. General. As a resident of Ayrfield Drive for over 40 years I have never once had any issues with walking for 5 minutes to the bus stop located on the Malahide Road at the Odeon Cinema, Bus Stop No. 1273. This stop is well serviced by numerous different buses and also is located at a safe and convenient place for the residents of Ayrfield.
