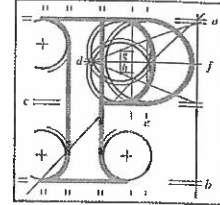

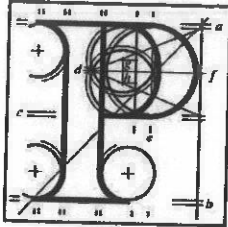



Noise pollution if wall currently in place which is approximately 9 feet tall and acts as a sound barrier is removed.


An increase in car parking from people outside of Ayrfield to use Bus Connect, another risk with volume of Cars and Motorbikes going through the estate.
