





This opening would produce a serious problem with antisocial behaviour and a significantly increased security risk by permitting easy access to criminal elements. The result is a heightened vulnerability to burglaries, car theft and vandalism by facilitating an easy escape route to evade Gardaí on the main road.

Our walled-in green space has served as a safe playground for our young children for decades. Any opening to this wall would deprive our community of this most valued amenity. It would undermine the peace of mind parents have regarding its safety, by exposing our children to a very busy and dangerous dual carriageway.

This proposal would cause an unwanted increase in traffic to our estate and particularly outside my home, 47 Ayrfield Drive, from drop-offs and pickups. The proposed new bus stop at the rear of my house and pedestrian crossing adjacent to our green on the Malahide Road would be in very close proximity to each other. This would cause an increase in noise and traffic pollution due to the constant stopping and starting of traffic at this location.

5. Grounds

This proposal would also be detrimental to the privacy of my home caused by the bus stop at the rear of my home overlooking my back garden and increased pedestrians passing the front and side of the premises.

This proposal would change our road from a peaceful and private place to a very public and busy area which is both unnecessary and unwanted by the local community.

Any perceived convenience envisaged by the NTA proposal for bus access would be vastly outweighed by the impact of the many threats it would cause.
