





am objecting to the open space between 45 and 47 Ayrfield Drive as it proposes clear public health and safety issues such as child protection issues, impacts the overall safety of the area and will cause an increase in anti-social behaviour due to the opening of the area. The open area will also allow direct access to dual carriageway for children who are used to playing outdoors in a safe, secure residential area. The child safety implications here are huge for the area. There is also a strong probability of a change in our low crime area to an area of high crime as it is easier to abscond from Gardaí. The open space between 45 and 47 Ayrfield Drive will also have a huge impact on amenities and the community as children will lose a popular green space, there will be unwanted direct access to a dual carriageway and noise pollution from a busy dual carriageway. The open space between 45 and 47 Ayrfield Drive will also result in major traffic hazards such as; Increased risk of road traffic incidents for our residents due to the large opening onto a dual carriageway. There will be an increase in vehicle parking for people wanting to use the bus connect service which will result in difficulty crossing the road and poor visibility which can result in serious incidents. Additionally, there will be an increase in traffic volume in the estate which raises serious safety issues with regards to residents and children who are used to low volumes of traffic. The points I have made above are the reasons as to why I am objecting and completely against the open space between 45 and 47 Ayrfield
