



We are a group of residents from Haverty Road and Carleton Road who have serious concerns in relation to speeding traffic on our road, particularly rat running during peak travel times.

We welcome the Bus Connect Core Bus Corridor Scheme as a major advance in public transport planning.

We support the proposal by National Transport Authority to restrict public right of way at the Haverty Road/St Aidan's Park junction.

We have campaigned for a number of years to make Haverty Road and Carlton Road safer for cyclists and pedestrians, particularly children and vulnerable adults. There are a high number of young children living on both roads and the roads are also used by school children attending St. Joseph's Schools on Marino Park Avenue.

A high number of commuting cyclists use this route currently and are at high risk from speeding traffic. The Bus Connect Scheme proposes to direct cyclists through Haverty Road and Carleton Road.

We have discussed our concerns with Dublin City Council, An Garda Siochana, National Transport Authority and Marino Residents' Association, but any action taken to date has been ineffective.

Motorists ignore a "No Right' turn into Haverty Road and speed through the road onto Carleton Road in order to avoid the traffic lights at Marino Mart en route to Malahide Road.

We believe that a barrier at the junction, as proposed by NTA, is the only solution to deter speeding traffic and make our roads safer.

There is ample room at this junction to create a turnaround space for emergency and other services. (They are currently regularly restricted by the amount of parked cars on the corners at this junction).

There are already a number of roads in our estate with similar restrictions that work successfully and have eliminated rat running.
