





We have been living in Ayrfield over 30 years having moved here with our 5 children. The residents of Ayrfield have always taken steps to ensure safety of the children and residents of all ages by working with the council to ensure that anything that could potentially effect the safety would not go ahead.

We are now lucky enough to have our grandchildren come to our home after school most days as well as have 2 of them live in Ayrfield we are always confident that they are safe.

We have a number of observations we would like to make about the proposed bus corridor on Ayrfield Drive as part of the bus connect scheme. Firstly I would like to address the fact that the meetings were happening in the middle of a pandemic, a time when everybody was being advised to stay indoors and in particular our generation who were told to cocoon. Therefore we could not attend any meetings and if we had been fully aware of what was happening we would have.

Ayrfield has only one way in and one way out for cars. This makes this
a safe enclosed space for people to live and children to play. If the wall



is removed then it allows for increased criminal activity, meaning that if anything were to happen the gardai would come in through Rathvale but they would have a direct route on to the Malahide Road from Ayrfield Drive.

- 2. To make way for a bus corridor the wall has to be knocked. This would also impact foot traffic as it would now be a shortcut to people from outside of Ayrfield to come through to reach anywhere on the Malahide Road. It would result in Ayrfield not being safe for children to play freely as they have all their lives.
- 3. The bus corridor would also have an impact on the car traffic coming into Ayrfield as can be seen anywhere in Dublin, if there is a bus stop or a train station nearby there is never any parking, even on residential streets. The streets of Ayrfield Drive and Newtown are narrow as it is and if parking was increased in the area there would be an increase in accidents as children cannot always be seen behind cars, in addition emergency services would not be able to move through easily.
- Laneways or open spaces which lead to main roads always attract anti social behaviour and we need to feel safe to walk around where we live, even if it is dark.
- 5. Children play on the green space on Ayrfield Drive every day. We have a green space in front of our house as well as on Rathvale but it is not as safe as there are roads the whole way around the greens.
- 6. The height of the wall ensures that nobody can climb over it as well as acting as a barrier for noise pollution.

- 7. Children will naturally want to explore the area which is incredibly dangerous as it is a dual carriageway. One side of the wall will have a 30kmh speed zone and the other will have 60kmh children do not see this.
- 8. The residents are fully aware of the speed limits (30kmh) and how to drive safely through the estate however if this estate is opened up to a dual carriageway for commuting purposes we would be very concerned with Ayrfield becoming a "park and ride" route
