





We have been living in Ayrfield since 2018 and the reason we chose to move to Ayrfield Drive was due to the incredibly safe nature of it. We both cycle to work every day and therefore are not opposed to the entire bus corridor or safer cycling. However we have a number of observations to make on the proposal for the bus corridor on Ayrfield Drive which is noted as beneficial for the residents:

- There is one way in and on way out for all cars, if this wall is removed it will expose the area to potential increased crime as the gardai will be able to enter one way however anybody conducting criminal activity will be able to exit directly on to the Malahide road and leave very quickly.
- As with any "laneway" areas there will be an increase in anti-social behaviour, Ayrfield Drive previously had a laneway and this was an issue and all neighbours campaigned to close this which was agreed.
- The children in the area and particularly on Ayrfield Drive play on this
 green space every day. Whilst we acknowledge there are other green
 spaces this is the safest one in Ayrfield given it is enclosed and on a
 cul de sac road with a small amount of traffic. The wall is high enough

that people cannot get over and therefore as parents we know that our children are safe whilst playing there.

- In addition to what the children of Ayrfield have grown up with we will be opening the area up to high volumes of people from outside of our estate that we do not know using it as a shortcut to reach different places whether that be the bus stop, the shops, cinema etc. This would mean not being in a position to allow the children out to play as often and regularly as they currently do as it would not be safe anymore. In this day and age when there are so many government campaigns to get children out playing with each other, fresh air, stepping away from computers the removal of this wall would result in the complete opposite.
- Further to this point is the fact that children are naturally curious beings
 and if they see an opening to a new road they will want to go and
 investigate this, we also have a number of children in the area who
 have additional needs and this space is vital for them. The potential for
 road traffic accidents is huge here.
- Ayrfield is heavily populated with children and a number of older people, the residents are fully aware of the speed limits (30kmh) and how to drive safely through the estate however if this estate is opened up to a dual carriageway for commuting purposes we would be very concerned with Ayrfield becoming a "park and ride" route as has happened in any other areas which are a quick route to public transport. The roads are already narrow as it is in Ayrfield Drive and




increased car parking would make it difficult to manoeuvre safely along Ayrfield Drive and into Newtown, also making it difficult for any emergency vehicles such as fire brigades and ambulances.

The wall on the green space currently acts as a shield from the noise
pollution on the Malahide road. Given the speed in which cars drive
down this road as well as the number of buses in the future route will
increase this even more.

Whilst we acknowledge the well meaning behind this proposal the residents of Ayrfield have clearly demonstrated that this is not wanted or needed. It is a 12 minute walk to the bus stop around at the Odeon cinema and a 15 minute walk to Lidi shops. The residents have all been doing this as long as we have lived here and have no problem with continuing to do so. The council have carried out a lot of work on the footpaths in the last couple of years making it accessible for everybody.

Throughout covid this green space was a hub for the community it has been so important to us, giving us somewhere to build memories, hold birthday parties, teach children about planting, learn football, how to cycle, throw a ball for our dogs and all in a safe, enclosed space without any risk to anybody.
