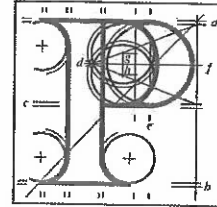

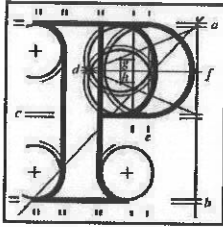

To Whom it concerns,

The breaching of the wall currently dividing Ayrfield Drive from The Malahide Road would in essence be the dismantling of a perfectly functioning housing estate. Ayrfield is now in its second generation of raising young children along with providing safe homes for our older neighbours. It's narrow roads already extremely congested with parked cars etc., could not possibly cater for the deluge of foot, cycle, scooter and subsequent car traffic that would appear should this scheme proceed. First time buyers, and other homeowners have moved to this area for the very reason that this area is relatively quiet by Dublin standards and this project would completely undermine this objective. The area in question, where the breach is proposed is currently a safe haven for small kids and their supervising adults. Breaking through this wall would obliterate a safe and secure facility and disenfranchise the whole estate. Before more aggravation and further potential upset occurs, I strongly urge you to discontinue with this particular section of your planned project. I'm sure and certain that your planners and engineers can come up with a more compassionate solution to this issue, one that can harness rather than diminish our local homeowner's confidence in your abilities.
