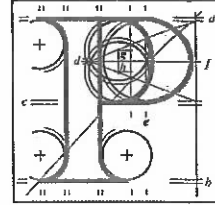

You will be notified of the arrangements for the opening of any such oral hearing.



How in heavens name can this continue with this new proposal. Nicola's attendance at C.R.C. is her whole life where she meets & socializes with her peers. and any threat to this daily routine would have devastating consequences for her. Also the inevitable increase in air pollution noise pollution must have a detrimental effect on the health of every person living on the road. Another point the post tunnel closes for maintenance work every Thursday <sup>night</sup> and every truck leaving Dub. Port heading northwards passes by my front door. with the bus lane & existing traffic lane there would be two lanes of trucks passing would you like to live
