An Bord Planeala

I wish to make strong objections to the Bus Corridor - Baggot Street - for many reasons, but in no particular order:

1. It would have a detrimental effect on deliveries to our business on Upper Baggot St. Supplies such as drums of perc (perchloroethylene) are delivered in large drums, as are large drums removed with waste. Also on cardboard boxes which arrive on pallets.
2. On-street loading and parking are vital to the survival of this area. Removal of loading bay and parking would cripple business.
3. Elderly people would be affected in crossing the road to the P.O. or pharmacy, etc. as would those in wheelchairs or parents with young children.
4. Buses are empty at the moment. Already, there are more bus routes than are required for Baggot St.
5. Buses should go straight along Northumberland Road/Mount St. rather than be diverted thru Baggot St. Village, ruining the Georgian Streetscape, along with the business and community of Pembroke Road and Baggot St.
6. Our customers travel to us from all over Dublin and other counties. Proposal to stop traffic from turning right onto Upper Baggot St. from Mespil will prove harmful to business. We currently give employment to 15/17 people. These jobs will be severely affected with a Bus Corridor. They travel from Clondalkin, Lucan and Leixlip to Baggot St.
7. To restrict Haddington Road to one lane at the Baggot St. junction will lead to harmful congestion.
8. Baggot St. Bridge is narrow, humped and not suitable for 100 buses an hour driving over it. Mount St. Bridge is large, flat and suited to traffic.
9. We observe that businesses across the street serve as a place to stop for private and commercial vehicles - these include Garda cars, ambulances and emergency services. This has always been the case, despite the yellow lines.
10. To change the footpaths would further damage the ability of businesses to operate and people to access the area. In total, on Upper Baggot St. are two Supermarkets, two Pharmacies, Hardware Shop, Post Office, Wine Shop, Beauty Salon, two Banks, Dry Cleaners, Dentist, Florist, three Pubs, Newsagent, Gents Clothing, Hairdressers, etc.
11. Sending buses up Pembroke Road, cutting off car access from Ballsbridge/Jurys end and Baggot St. would cripple the business community in Baggot St.
