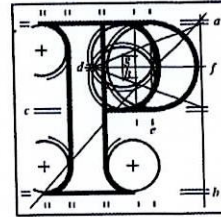

Dear Ms Caulfield,


We refer to your letter dated 02/06/23 re BusConnects Belfield/Blackrock to City Centre Core Bus Corridor Scheme Co.Dublin

We question strongly your decision not to allow an oral hearing and your conclusion that the matter can be adequately dealt with by further written submissions.


