AS A RESIDENT LIVING IN WILLOW CRECENT IN PRIMROSE GATE
ADJACENT TO THE PROPOSED DEVELOPMENT, I HAVE THE
FOLLOWING CONCERNS:

1-The proposed pedestrian entrances on both sides of Willow Crescent green is extremely concerning for me. The proposed entrances would open onto a quiet cul de sac, directly on to residents parking spaces and the front of their homes. As a parent of young children and I am sure I can speak for the parents of all the children that play on the green, access to our cul-de-sac is a definite no. I am also aware that the estate management company has said no to this.

Statistics have proven that any entrance linking a green area into a Private estate or linking two estates would pose a threat to our children's safety. It would also increase footfall resulting in noise and litter pollution, antisocial behaviour and potential increased thefts.

The current infrastructure in Willow Crescent could not accommodate any increased footfall whether by car or on foot. Any increase in cars also poses a risk to children playing safely as a number of houses have no front garden hence the green area and the pathways surrounding this are essential for children to play in a safe and established environment. Electric scooters, bikes etc pose further risk as these are now a common form of transport for all ages.

I would suggest another inspection of the proposed openings is carried out.

2-No change to any the perimeter in Willow crescent or the estate as it is a private estate

3-Planning should be turned down until an indepth wildlife study is conducted. Hedgehogs, foxes etc are commonly seen in Willow Crescent. These animals are being pushed from their natural habitat.

4-No formalized plan for schools as expected. It was my belief three schools were to be built in that field. The proposal should be turned down until schools and amenities are built first.

5-Noise pollution from build as working from home.
