

To whom it may concern,

Re: Liffey Valley It City Centre, Core Bus Corridor Scheme Re Part III (Section B)

We the below undersigned wish to lodge our complaint in regards to the proposed restriction of the existing public right of way at the corner of O'Hogan Road and Ballyfermot Road in the County of Dublin.

Our objection to the proposed restriction is based on several factors outlined below:

- The notice outlining the proposed restriction appears to use an outdated map as a
 reference. Several developments to residences that have existed for many years have been
 omitted from deposit map reference 0007-DM-0012.
 As such, we do not have confidence that due diligence has been applied in relation to the
 viability of the project and are concerned that surveying of the area has not been thorough.
- 2. The proposed restriction removes the primary access point to the main Ballyfermot Road from many residential properties, situated on O'Hogan Rd, Lally Rd, Decies Rd, O'Moore Rd and also as a secondary access point to Cremona Rd and Landen Rd. These areas are highly populated by both families and elderly residents. Removing a key artery would result in great disruption to the lives of these residents. It would also result in an large increase in traffic in other access points such as Garryowen Rd, Decies Rd and Landen Rd, which would be disruptive to many households and families. Especially those with young children who frequently play on the street.
- 3. The proposed restriction removes a key access point to the area for emergency services. As previously stated, this area is home to a high number of elderly residents, removing the access point would mean emergency services would be required to take alternative and less direct routes to a large number of residences, which could result in a delay of urgent and emergency care to people in need.
- 4. The existing bus stops and park are already well known sites for antisocial behaviour. We are highly concerned that a new stop situated in the proposed area would result in further antisocial behaviour including loitering and illegal dumping.
- 5. The junction at the proposed restriction is currently controlled by traffic lights and contains a pedestrian crossing. The proposed map and plan make no indication that these traffic calming measures would be retained. This would result in an increase of traffic volume and restrict pedestrian access to parallel roads and the opposite bus stop. Which would be massively counterintuitive to the promised reduction in travel time which is allegedly to be the result of the bus corridor works.

We hope that you take these considerations into account and reconsider the proposal. We feel that the proposed restriction would be a cause of great disruption and an inconvenience to residents and that it's development is short sighted and shows a lack of due consideration for the needs of the community.
