

To whom it may concern,

While it is clear that improvements to Galway City's public transport system are urgently needed, this plan appears to take a disintegrated approach with regard to balancing the needs of different road users, as well as residents of the city.

It is proposed that several houses are compulsory purchased and demolished to make way for the upgrades, and in some instances this is to allow for more car parking spaces and this at a time when housing shortages and homelessness are wreaking havok on the very fabric of the city.

There are also very few additional cycle lanes proposed in the plan. The stretch of new cycle lane on the Dublin Road from Galway Hospice to the Huntsman is welcome, but it is unlikely to encourage modal shift to any significant degree, as the road will continue to be treacherous for cyclists travelling past Galway Hospice towards Renmore.

The traffic problem in Galway City would be more efficiently addressed with an east-west orbital bus route from Knocnacarra to Parkmore over the Quincentennial Bridge. This would reduce the need in the shorter term for so many bus lanes going through the city centre and allow for more cycling and pedestrian infrastructure.

I am therefore recommending:

- that no homes are compulsory purchased and demolished.
- an orbital east-west bus route over the Quincentennial bridge is installed to reduce traffic congestion in the short term.
- more walking and cycling infrastructure is included in the plan, particularly in the city centre, and on the Dublin Road and east side of the city generally.
- that other longer term solutions such as a very light rail system are explored.

These recommendations are made with a view to reaching the aims of the Galway Transport Strategy to reduce congestion, and the emissions reduction targets as required by the Climate Action and Low Carbon Development Act 2021.
