

Dear Sirs / Madam,

We are writing to make an observation on the above application on behalf of Yeats College, College Road, Galway City.

As part of this traffic system proposal, they have proposed that a gated access with restrictions to certain traffic movement at College Road which could see a potential traffic build-up if the necessary turning capability is not incorporated into the layout at this location, for example the introduction of a mini-roundabout. Otherwise, you have potential of multiple vehicles undertaking two point turns or similar manoeuvres on the main road to allow them to make their return journey up college road and to make their way to the desired route proposed by Galway City Council.

As this restricted access is to the immediacy of Yeats College this current layout proposal appears that it would have a detrimental impact in the accessibility of Yeats College for staff, Parents, students, school visitors, potential emergency services and school deliveries.
