

As 43 years residents we have had no letters of application or notification of proposed or completed plans. We have been notified of new pathways but no other infrastructure plans for the area.

There are many examples of supporting materials that could be submitted if Pleanála had notified us with transparent information of these plans.

There has been no Citizen Engagement made with any residence. One of the first and no doubt founding points of the Climate Action Plan 2021.

Although I am living on only one area of this over all plan. The entire proposal needs careful reconsideration as the proposed changes to the public sector before 2030 for home and remote working do not marry with any of these changes.

Similar upsetting changes have been made without residence consent on the Northside of the city in the 1980's with large compensations and court cases following in years after. A behaviour we do not wish to repeat for either party.

We ask for these plans to be delayed until Spring 2023 when residence have time to obtain supporting material and correct form of agency to deliver all arguments together as a community.


