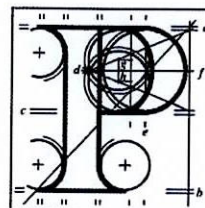

I am writing to you

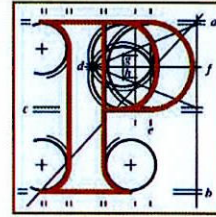
to object to the Proposed BUS CORRIDOR on the Finglas RD opposite Blasnevin Cemetery. The stretch of Road I am concerned about is the Road in front of Claremont houses and Cloreville GROVE. The Proposal is to widen the RD in front of Cloreville houses by encroaching on the small PARK with the Mature TREES, and to REMOVE the existing car park spaces, and to move the car park to a green space beside Cloreville GROVE, metres from my front door. We have a car park in the estate already, which is 90% of its time empty, yet TFI want to put another car park right beside my HOUSE. My concern with moving the BUS route closer to my House is the increase in noise from 9:00am to 7:30pm. The park before my House is the only green space for lots of Houses, there are persons Retirement Homes beside the park and
