

Dear Sir/Madam,

I wish to make a submission in relation to the Preferred Route Options set out in the core bus corridor Finglas to Phisborough document to be submitted to An Bord Pleanála during Q4 2020 for its consideration and determination where I understand a formal statutory consultation process will be undertaken as part of the process.

I live (at 117 North Road) directly beside the compulsory land purchase order of Site Notice No 19 (See Annex 1). As you can see from Annex 2 the plans show that as part of this proposed process, to open the wall for pedestrian access is being proposed in a laneway directly at my side wall would be made as a walkway for residents of the North Road to have access to the bus connects terminal.

This land at the side of my house is already a huge issue for residents on this road. We have huge antisocial behaviour taking place on this land in the form of constant dumping, drug taking, gangs drinking alcohol, open drug selling, prostitution, selling of robbed goods, homeless in tents etc. This has been reported many times over the last years to the Finglas Guards and our local TD Paul McAuliffe and Councillors Keith Connolly and Briege MacOscar who have tirelessly lobbied to Dublin City Council on our behalf.

To now install a laneway on this land (with trees all around also) would only compound the anti-social behaviour and indeed encourage more of the same. We have already had many complaints of women crossing the bridge at night time where they have been approached by drug takers under the influence of drink, drugs. At a time when laneways are being closed up in Finglas this proposal seems absurd.

We the Residents would be happy for you to attend a site visit etc to discuss this matter fully and we would propose moving the walkway to the end of the road where an opening already exists, it would be safer for all involved and this opening also follows the metro plans.
