

We wish to make the below considerations for number 29 Walkinstown Road, Walkinstown, Dublin 12 D12VF5W

We occupy no. 29 and have spent considerable amount of time and money to do up the front of our house to keep our kids safe.

Keeping them safe is paramount.

We have installed electric steel and cedar gates to keep our kids safe from a busy road.

When replacing them they should be to a acceptable standard and ascetic as our current ones.

We would like assurance that our two young kids will be as safe while works are on going and ease of access is vital when entering and existing our property.

Fencing and plants have been sown and built to make our house and road more "attractive" and secure at a cost of time and money.

The loss of our driveway will decrease the value of our home and we would like to be compensated for this loss.

The quality of life will be affected by the on going works and stress of trying to enter and leave our home with 2 young kids should be considered when compensating us.

The bus will be closer and more frequent so upgrading our windows because of noise pollution should be forthcoming.

Sound reducing tar mac should be used to help elevate some of this noise.

Our young kids and our sleep will be affected if works are starting or finishing at certain times so this should be considered when compensating us and scheduling work hours.

We had works carried out recently on our road near the halfway house pub and a stop go system was put in place. The works went on until midnight and you could hear cars beeping their horns because the stop go system keeping us up for nights at a time. We think this was because the traffic light that are in use normally were not covered so people were beeping when they went green not knowing that there was a stop go system in place.

We rang the council to complain about this.

This effected our quality of like and our kids sleep for the week it was on going.

We hope that this will not be the case when the bus connects starts up as losing sleep would be a major health issue for a long period of time.

I think you should put all cables underground now while works are starting that are possible to do so to make our neighbourhood more ascetic and replace poles for wires with trees.

Trees should be planted where possible to dampen sound and make the neighbourhood better.

Access to our lane is needed daily as we have had to upgrade our shed because we are losing part of the driveway to park vehicles. Considerable costs were incurred because of this with construction of the shed to house our vehicle as they won't fit in the front garden when we lose part of the driveway.

We will need access 24/7 to the lane to go to work, bring kids to creche, playschool and social occasions. This is paramount.

You should make electric busses a priority for routes where people losing their driveway as they will reduce noise pollution for people effected. I was in Budapest and their electric bus system makes our bus system look dated.

The dust and noise created when working on the corridor will affect of quality of life and health so all efforts should be made to reduce both and workers should be respectful of all residents and listen to their concerns.

Dust from works will mean dirtier cars, windows and driveways meaning more trips to the car wash and cleaners needed which will be a extra expense for the occupier of the homes effected. Appropriate remuneration should be paid.

We hope these works will be carried out in a safe and efficient manner so that all parties can enjoy a quality of life and come out the other side with a more beautiful neighbourhood with addition of some trees to footpaths that will be lost from people's gardens because of construction.
