

To Whom It May Concern:

We wish to bring to you attention several objections to the above planning application:

1: Increased Traffic Congestion on Old County Road, Dublin 12

As residents of Old County Road (no. 24 & 26), we have strong reason to believe that this scheme will divert huge amounts of traffic to Old County Road, with the plans to make Bangor road and Clonard Road one way streets. Old County Road, not built to receive a large amount of traffic, is already a busy road at peak times. Especially in the mornings with a large volume of traffic due to the road use to drop children off to Loretto's school Sundrive. During school drop off and collection times it is extremely difficult to get out of our driveways, with extra traffic we fear we will be "imprisoned" in our own houses (exit toward Crumlin Road can take up to 15/20min at times)

2. Pollution from the Construction Compound and removal of green space

The plans to use the green area beside the HSE building (Old County Road Health Centre) as a construction compound will add more pollution to the area. Old County Road was not built to carry huge volumes of materials or extra parking (for builders working on the Bus Corridor). We lack green spaces in the area and to remove this would be a disaster for Old County Road residents.

In general we support the concept for improving public transport and cycle lanes but diverting huge volumes of traffic down slip roads that do not have the infrastructure to accommodate it does not make sense. There is significant opposition to these proposals amongst fellow residents.
