



This proposed change will restrict access to the Crumlin Road form Clonard Road. This I believe will create an unacceptable level of additional traffic at the junction of Old county Road and the Crumlin road at one end and Old County Road and Windmill Road at the other Road. It will also result in rat runs being created on Downpatrick Road, Saul Road and Slane Road. These rat runs and the resulting additional traffic will result in residents being exposed to excessive exhaust fumes, danger to children cycling playing and walking on these usually quiet roads (Slane, Saul and Downpatrick Roads).
