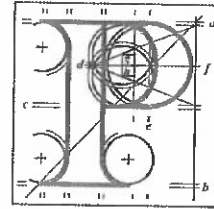

I AM STRONGLY OBJECTING TO THE PROPOSAL OF A TWO WAY CYCLE TRACK GOING THROUGH YORK RD, PEMBROKE COTTAGES, CAMBRIDGE PARK, CANNON MOONEY GARDENS FLAT COMPLEX WHICH THEY FORGOT TO MENTION, ST PATRICK'S VILLAS, ST BRENDAN COTTAGES, AND STRASBURG TERRACE THESE QUITE PLACES HAVE ENTERING AND EXIT TO RINGSEND PARK WITH A POLICY **NO BIKES ALLOWED** WITH ELDER, TEENS, CHILDREN, YOUNG FAMILIES, DOG WALKERS, THREE LOCAL SCHOOLS AND PLAY SCHOOLS FEEL SAFE USING THE FACILITIES, BUT THEN THERE CYCLIST RACING THROUGH THE PARK WHEN YOU CONFRONT THEM TO SLOW DOWN THEY GO FASTER. I LIVE IN PEMBROKE COTTAGES THE WIDTH OF THE ROAD IS ABOUT 7 METERS WITH CARS PARK EACH SIDE, WE HAVE NO FRONT OR BACK GARDENS WHICH OUR CHILDREN AND GRANDCHILDREN CAN PLAY SO THEY PLAY ON THE STREET, WE ARE ALREADY INUNDATED WITH CYCLIST COMING THROUGH AN **NO ENTRY** AT YORK ROAD SOME CYCLE ON THE FOOTPATH SO COMING OUT OUR FRONT DOOR AND CROSSING THE ROAD IS VERY DANGEROUS, **THIS IS HAPPENING NOW**. THERE WAS AN INCIDENT HAPPENED TWO MONTHS ONE OF THE CHILDREN WAS KNOCK DOWN WHILE PLAYING BY A CYCLIST WHO NEVER STOP, THIS IS ON REPORT IN IRISHTOWN GARDA

STATION. TRAFFIC CALMING TO DEVASTATE A WHOLE
