Good Afternoon Councillor.

No timeframe has been given to Eirgrid for the lodgement of the missing information.

The EU Regulation does, however, state [Article 10.1(b)] that the pre-application procedure should take place within an indicative period of 2 years. The Regulation at Article 10.2 does allow for the competent authority (An Bord Pleanála PCI Unit) to extend the overall PCI process (pre-application procedure and statutory permit granting procedure which should take place within an overall 3 years and six month) by 9 months on a case by case basis.

The PCI process commenced on 2<sup>nd</sup> July, 2014 when An Bord Pleanála acting as the competent authority acknowledged the notification from Eirgrid.

I will let you know when the missing information has been submitted.
