Thank you for your email updating me on the request for missing information. Your email initially led me to believe that no meeting had taken place between ABP and Eirgrid in regards to this matter. Therefore, I was quite surprised to see on the Eirgrid website that a meeting did in fact take place with ABP on 16th December. The statement on the Eirgrid website is not transparent insofar as it does not qualify exactly who or what unit of ABP was present at this meeting. Furthermore, I have already been contacted by the Monaghan Landowner Group regarding the nature of this missing information insofar as it could be of an environmental nature necessitating access to lands by Eirgrid or its agents, so far denied by the landowners concerned. While I realise that you are probably not in a position to make public exactly what this missing information is, I would very much appreciate it if you could confirm that access to lands will **not** be required in order for this missing information to be compiled.
