nasfár gréasáin tarchuir leictreachais reatha Thuaisceart Éireann agus na hÉireann idir Turleenan, Contae Thír Eoghain agus Fearann na Coille, láimh le Baile an Bhóthair, Contae na Mí. Sainaithníodh an t-idinascach seo mar Thionscadal Comhleasa de bhun fhorálacha Rialachán (AE) Uimh. 347/2013 ó Pharlaimint na hEorpa agus ón gComhairle an 17 Aibreán 2013 maidir le treoirínte le haghaidh bonneagair tras-Eorpaigh fuinnimh.

An Fhorbairt Idirnasctha Thuaidh-Theas 400 kV a bheartaítear, atá suite i gcontaetha Mhuineacháin, an Chabháin agus na Mí, a bheidh ina hábhar don iarratas ar cheadú, tá sí thart ar 103.35 km ar fad agus cuimsítear léi na príomhghnéithe seo a leanas:

(i) Líne tharchuir lasnairde 400 kV nua ciorcaid shingil (a chlúdóidh thart ar 100.5 km ar fad i gContae Mhuineacháin, i gContae an Chabháin agus i gContae na Mí) a shíneadh ó dheas den chuid is mó ag an teorainn dlinse le Tuaisceart Éireann (idir baile fearainn Doohat nó Crossreagh, Contae Ard Mhacha, agus baile fearainn na Léime Giorra, Contae Mhuineacháin) go baile fearainn

kilometres located in Northern Ireland) will link the existing electricity transmission networks of Northern Ireland and Ireland between Turleenan, County Tyrone and Woodland, near Batterstown, County Meath. This interconnector has been designated as a Project of Common Interest (PCI) pursuant to the provisions of Regulation (EU) No. 347/2013 of the European Parliament and of the Council of 17th April 2013 on guidelines for trans-European energy infrastructure.

The proposed North-South 400 kilovolt Interconnection Development located in Counties Monaghan, Cavan and Meath, which will be the subject of the application for approval, is approximately 103.35 kilometres long and consists of the following principal elements:

(i) A new single circuit 400-kilovolt overhead transmission line (covering a distance of approximately 100.5 kilometres in the counties of Monaghan, Cavan and Meath) extending in a generally southerly alignment from the jurisdictional border with Northern Ireland (between the townland of Doohat or Crossreagh, County Armagh, and the townland of Lemgare, County

Bogganstown (Toghroinn Chúil Mhaoilín), Contae na Mí. Ina theannta sin, trasnaíonn an líne tharchuir a bheartaítear an teorainn dlínse le Tuaisceart Éireann in dhá áit – ó bhaile fearainn na Léime Giorra, Contae Mhuineacháin, isteach i mbaile fearainn na Croise Báine, Contae Ard Mhacha, agus ar ais go baile fearainn na Léime Giorra, Contae Mhuineacháin. Cuimseoidh an líne tharchuir sin 299 struchtúr tacaíochta cruach laitise nua (atá idir thart ar 26 m agus 51 m os cionn leibhéal na talún), mar aon leis na seoltóirí, na hinslitheoirí agus gairis eile lena mbaineann.

In addition, the proposed transmission line crosses the jurisdictional border with Northern Ireland at two points - from the townland of Lemgare, County Monaghan into the townland of Crossbane, County Armagh and back into the townland of Lemgare, County Monaghan. This transmission line comprises 299 number new lattice steel support structures (ranging in height from approximately 26 metres to 51 metres over ground level), with associated conductors, insulators, and other apparatus.

The proposed new transmission line extends across the following townlands of County Monaghan, County Cavan and County Meath:

(ii) Is gá mionathruithe a dhéanamh ar thrí líne lasnairde 110 kV reatha. I measc na mionathruithe, cuirfear sraitheanna cuailí breise isteach agus / nó cuirfear sraitheanna cuailí níos ísle (idir 11.5 m agus 19 m ar airde os cionn leibhéal na talún) in ionad struchtúir reatha sna láithreacha seo a leanas:

(ii) Modifications are required to three number existing 110 kV overhead lines. The modifications comprise the insertion of additional polesets and/or replacement of existing structures with polesets of shorter height (ranging in height from approximately 11.5 m to 19 m over ground level) in the following locations:

- The vicinity of where the proposed 400 kV overhead transmission line intersects with the Lisdrum Louth 110 kV transmission line, in Drumroosk, County Monaghan.
- The vicinity of where the proposed 400 kV overhead transmission line intersects with the Louth-Rathrussan 110 kV transmission line, in Corrinenty and Corbane, County Monaghan.
- The vicinity of where the proposed 400 kV overhead transmission line intersects with the Arva-Navan 110 kV transmission line, in Diméin Bhaile Ghib (Gibstown Demesne and Taitin (Teltown), County Meath.

(iii) Ciorcad 400 kV nua a shínfidh thart ar 2.85km feadh an taoibh thuaidh nach bhfuil á úsáid faoi láthair den líne tharchuir 400 kV atá ann cheana idir an tSeansráid agus Fearann na Coille, a shínfear soir ó bhaile fearainn Bogganstown (Toghroinn Chúil Mhaoilín) a fhad le Fostáisiún Fhearann na Coille 400 kV de chuid BSL atá ann cheana i mbaile fearainn Fhearann na Coille, Contae na Mí, agus a thrasnóidh na bailte fearainn seo a leanas i gContae na Mí: Bogganstown (Toghroinn Chúil Mhaoilín), Curraghtown (Toghroinn Chúil Mhaoilín), Gaulstown (Toghroinn Chúil Mhaoilín), Hayestown, Creemore agus Fearann na Coille. Na struchtúir thacaíochta cruach laitíse chiorcaid dhúbailte atá feadh na líne sin atá ann cheana, tá siad éagsúil ó thaobh airde de, idir thart ar 52 m go 61 m os cionn leibhéal na talún.

(iv) Oibreacha gaolmhara ar shuíomh atá thart ar 0.544 ha ar achar laistigh d'Fhostáisiún Fhearann na Coille 400 kV de chuid BSL atá ann cheana agus fíorchóngarach dó i mbaile fearainn Fhearann na Coille, Contae na Mí, lena n-áirítear: síneadh an bhábhúin atá ann cheana siar (thart ar 0.231 ha), lena n-áirítear mionathruithe gaolmhara ar an gclai pailise 2.6 m ar airde atá ann

(iii) The addition of a new 400-kilovolt circuit for approximately 2.85 kilometres along the currently unused northern side of the existing Oldstreet to Woodland 400-kilovolt transmission line, extending eastwards from the townland of Bogganstown (ED Culmullin) to the existing ESB Woodland 400-kilovolt substation, in the townland of Woodland, County Meath, and crossing the following townlands in County Meath: Bogganstown (ED Culmullin), Curraghtown (ED Culmullin), Gaulstown (ED Culmullin), Hayestown, Creemore and Woodland. The existing double circuit lattice steel support structures along this existing line range in height from approximately 52 metres to 61 metres over ground level.

(iv) Associated works on a site of approximately 0.544 ha within and immediately adjacent to the existing ESB Woodland 400 kV substation, in the townland of Woodland, County Meath to include: a western extension of the existing compound (of approximately 0.231 ha) including associated modifications to the existing 2.6 metre high palisade

(vi) An fhorbairt ghaolmhar agus choimhdeach ar fad lena n-áirítear oibreacha a chuimsíonn nó a bhaineann le tógáil agus le tochair bhuan agus shealadach.

The Board did not consider that it was conflicted in any way by the separate administrative role fulfilled by An Bord Pleanála as the Competent Authority for Projects of Common Interest.

2. Community Gain

The Board noted the applicant's proposals in respect of community gain as set out under Section 5.5.3 of the Planning Report. The Board considered that the approach was clearly stated, with only minor details to be finalised, and did not consider it necessary to modify the applicant's proposal or to re-inforce the applicant's commitment in this regard by means of a planning condition.

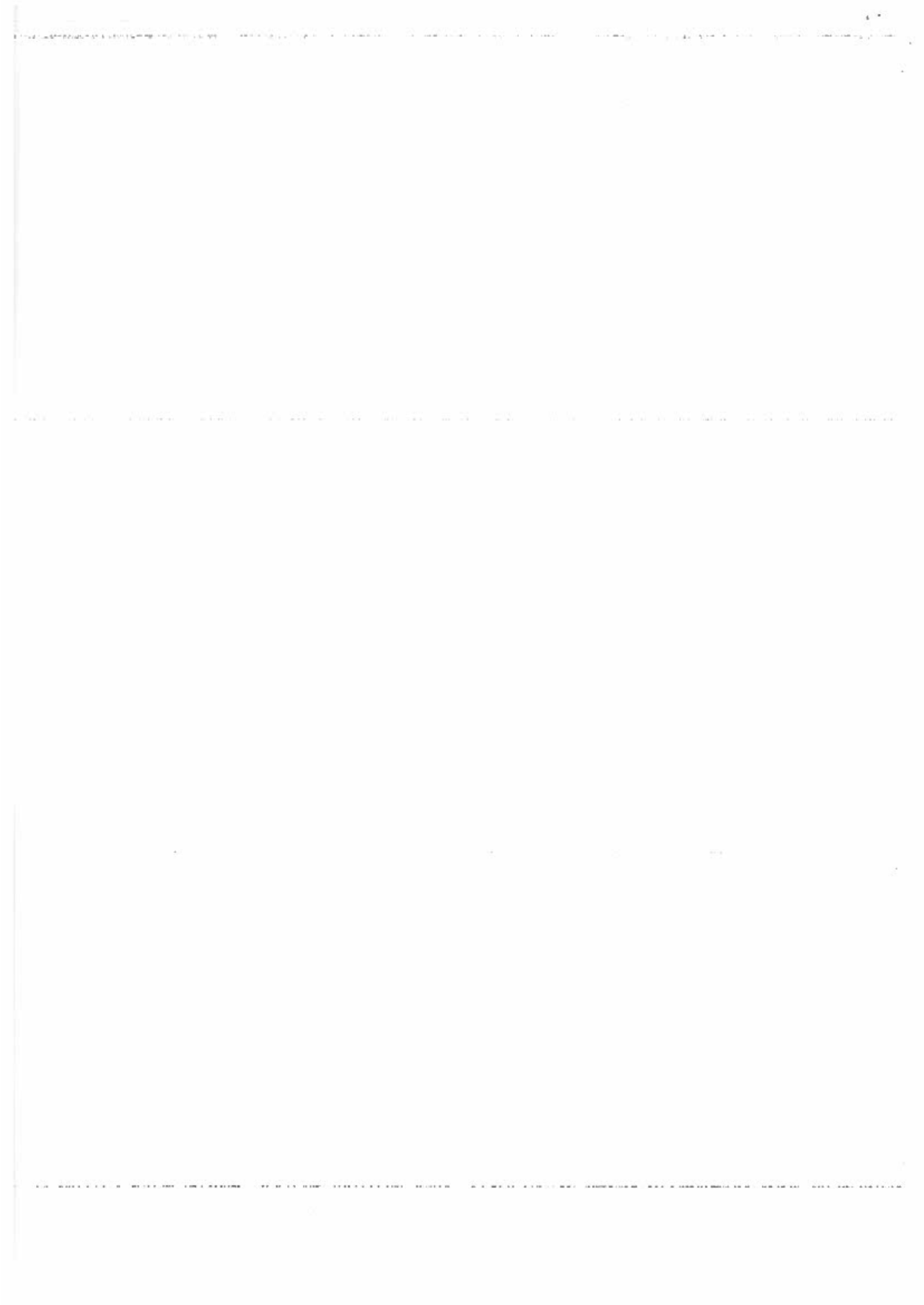
