

Greenlink PCI Project – Next Steps in Process as outlined at Meeting of 31/1/2019.

- As a guide, please refer to the Manual of Permit Granting Process
 Procedures, in particular pages 19 to 25, available on our website.
- In particular, the following are the next procedural steps as discussed:
- Greenlink is to confirm that all required permits have been listed and in relation to the CRU, Greenlink is to resolve any issue concerning a consent under section 14(1)(i) of the Electricity Regulation Act, 1991 as amended.
- ABP(CA) notes that your letter and attachment dated 17/2/20 lists a consent required under section 14(1)(i) of the Electricity Regulation Act, 1991 as amended.
- A list of consents is to be forwarded to ABP(CA).
- ABP(CA) notes that your letter and attachment dated 17/2/20 lists a schedule of permits (consents).
- A detailed schedule (Article 10.4(b) of the EU Regulation 347/2013) which shall specify at a minimum the matters set out in Annex VI (2) is to be drawn up.
- ABP(CA) will now proceed to contact those consenting authorities listed and request their input into the schedule, particularly, in relation to the duration of the individual stages of the procedure.
