

Missing Information in Section 48/49 Applications

CRU have identified missing information in our application and also missing supporting documents:

Missing Information in Application Form:

Planning Permission:

Up-date: A draft Application File was submitted to SID via PCI on the 12th June. It is expected that the final application file will be submitted to SID in October 2020. GIL expect to obtain planning permission in Q1/2 2021 which will then be forwarded to CRU.

Permission from Wexford Co. Co.

Road opening licences will be sought from Wexford Co. Co. prior to work commencing. A detailed construction schedule will be required in order to apply for the appropriate licences which will not be available before Q2, 2021.

Permission from Irish Rail:

The DC cable will be installed in the road under two railway bridges. The railway is disused. GIL are in discussions with CIE group property with regard to obtaining a licence for the installation and commercial discussions are on-going.

GIL have received a letter of consent from CIE to submit planning application.

Landowner Agreements:

In connection with the CRU's section 48 and 49 consents, GIL requires 13 wayleave option agreements to install cable across private property where, for technical reasons, installation in the public road is not an option.

For each of these landowners (except one where discussions are ongoing) we have signed planning consent letters to submit with our final planning application. GIL expects to submit all landowner planning consent letters with the final planning application. We have summarised the status of the landowner consent letters and land agreements in the following table:

Photocopies of all the affected Landowner Agreements and Letters of Consent:

GIL have 9 of 12 landowner agreements on file. It is expected that all agreements will be provided with our final application.

GIL have 11 of 12 letters of consent on file. It is expected that all 12 will be available to be provided with our final application.

Correspondence with affected landowners who have not given their consent:

GIL do not anticipate that any such correspondence will be required since we expect to achieve consent with all affected landowners.

Photocopies of planning permissions:

Will be provided to CRU as soon as received from SID.

Photocopy of connection offer from relevant system operator:

GIL have a connection offer from EirGrid ref no. P285-AM-OL dated 5/11/2019. This will be provided with our final application.

Photocopy of CRU Authorisation to construct or reconstruct a generating station:

This is not applicable to GIL. An Authorisation to Construct an Interconnector will be provided when received from CRU.

Photocopy of route map with folio boundaries clearly marked and a sequenced list of traversed landholdings, detailing folio number, owner, occupier, land type:
