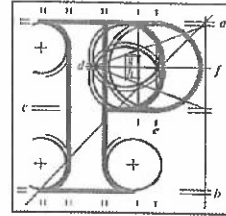

Dear Mr Thornton,

I am writing in support of the residents of Ayrfield Drive regarding the CPO of land for the Bus connects project.

I believe that the removal of the existing wall and the disruption of the current usage of the green as a safe play place for children on balance is not fair to the residents and the alternative access is possible notwithstanding the increase in permeability. The substantial change to the local amenity of residents is not one that would be supported easily by many communities and on balance I believe the potential benefit does not justify the loss of current amenity to residents. I remain in support of the bus connects scheme and the promotion of walking, cycling and public transport over the private car, but in this instance I don't believe the balance struck is appropriate.
