

The premise for the scheme is bus connects involving the knocking down of a wall at the top of our road, resulting in our cul de sac having direct access to the N11, an 80km/hr road.

This suggested change shows complete disregard for the realities of looking after little children. A child by this change will be unnecessarily exposed to the risk of wandering onto a dual-carriageway.

Our road is home to our children and other families with small children. Our children play at the top of our cul-de sac, as it is safe. The proposed changes beggar belief. They will result in our road being directly connected with an 80km/hr road. This road is home to our children and is not just a corridor or a thoroughfare. It is a safe, secure and quiet cul de sac where our children can play freely with their friends.

The scheme as it impacts the green verge adjoining South Park will change the nature of our road, creating dangers for our children where they are exposed to the N11, an 80km/hr road. I also have concerns that people will use our road as a through way to other roads, using scooters etc. Creating risks for our children. We purchased our house knowing that our road is a cul de sac. At no time were we consulted by Bus Connects re the change proposed.

We never envisaged that our road would change to accomodate a laneway onto the N11.

It is extremely unclear what the benefits of this change are, particularly as a laneway is in place only a few metres away. This laneway connects the N11 to Beechpark just a few metres away. There is no need for a new laneway. This laneway has been in place for in excess of 20 years, why it needs to be duplicated disrupting our road and neighbourhood is unclear.

While the benefits are unclear and I would say do not exist. The risks are very clear:

- (i) The addition of a laneway to a quiet cul de sac with direct access to the N11 will create a road that is not safe for our children for the reasons described above.
- (ii) From a security perspective the road will be less safe for all residents on the road, as the road becomes a throughway with people going up and down it twenty four seven.
- (iii) People will use the road for parking creating difficulties for residents.

We also have large concerns around the lack of transparency and consultation around this process.
