

As a Community we are very concerned about the impact such massive disruptions will cause to our neighbourhood. We are concerned about the effects of the proposed changes to our environment and the health and safety of our residents.

- The danger of bicycles/scooters/pedestrians colliding between underpass and ramp.
- The impact extending the underpass and having pedestrian access above our green area, re anti-social behaviour.
- Children, animals accessing the busy N11 from our green area.
- Adding a bus stop at our estate will increase the amount of cars using our estate for drop offs/pick ups and parking.
- The added foot fall in the estate will result in a significant reduction in privacy and exclusivity in our community and will likely see an increase in graffiti and litter.
- The loss of the trees which will affect privacy, increase noise pollution and contribute to overall pollution.
