

The issues raised in Shankill are unique along the City Centre to Bray route. Fair procedure, natural justice and best practice require either:

- 1. an oral hearing to tease out the issues enabling a balanced decision to be made, or
- an approval with modifications as suggested in your letter of 13 October 2023. Such modifications could exclude the Loughlinstown to Wilford Roundabout segment, or require those roundabouts to be linked by the T11 link now proposed by TFI. In the latter case, the Dublin road would be unaffected except perhaps by including recessed bus stops in the village.

Finally, the proposed CPO at the Barbeque Centre will clearly have very serious adverse consequences for most of the 11 businesses operating from there and is likely to be catastrophic for some of them.
