
Further to your letter dated 2<sup>nd</sup> January, 2025 in the above, we have been advised by our client to make comment on the conditions contained in Donegal Co Councils letter to you dated 18<sup>th</sup> December 2024.

**Condition 1a.** Because of our client's substantial financial outlay in getting the current application for Substitute Consent to this stage our client would like to request that the 5 year time period indicated by Donegal Co Council for the operation of the quarry be extended to 20 years.

**Condition 2a.** It should be noted that some of the existing quarry faces have been in place for many years going back to when Donegal Co Council used the quarry.
