Re: Submission on the proposed N6 Galway City Ring Road Motorway Scheme 2018.

Dear Sir / Madam,

I am writing to you to inform you that I object to the creation of this N6 Galway City Ring Road Motorway. I send this submission in to you An Bord Pleanála for the following reasons, considerations and arguments.

Main Reasons

My major concerns/reasons to begin with is the personal effect of this Ring Road motorway is having to myself and my family. The impact of this N6 Motorway is having a huge impact on my mental health and physical health. I am fraught worry, stress and concerns on the proposed scheme. My Quality of life is going to be drastically changed by Galway County Council constructing a new motorway through our area if they get the all clear from you An Bord Pleanála.

My Area of residence where i dwell is going to become more polluted due to the introduction of noise pollution introduced with the creation of this motorway. It is going to become a huge adverse factor, it will affect my well being and that of my family's well being. It will also become a lot more noisier than acceptable levels of hearing and that is not acceptable to me or my family when i live in a peaceful, serene area without no interruptions of noise disturbances whatsoever as it currently stands at present where i reside.

Next on the list of concerns is Traffic pollution. This is another negative effect that they are proposing to bring to my area i live in. It is a major health concern to me as i see it. My quality of clean breathing air is going to be drastically reduced also affecting my family aswell. This is also going to have a harmful effect on the flora and fauna of my residence and the surrounding neighbourhood. I grow also a lot of plants in my garden and this motorway is going to have a negative adverse effect on my trees and plants at my Home. On top of that it is releasing harmful CO_2 emissions from this proposed motorway into the atmosphere in not just my region, the whole region of all the motorway plan from east galway city to west galway city. As of recent were we not told that Ireland as a country had to start reducing carbon emissions to reduce the effect of global warming by environmental agencies not just from Ireland but all over the world. Instead of reducing carbon emissions this proposed motorway does the opposite it will increase pollution making it worse.

My third major concern is the impact of the construction phase of this motorway on the structural integrity of my residence where i reside. Will this motorway be conducting controlled demolition blasting in the area or surrounding area near my home and it so will that lead to damage to my property from the vibrations of the blasting if stone needs to be removed the likes of granite stone etc. If cracks start to appear on my property due to the actions of the construction phase. How does that action help me all it doesin't is weaken my property structure. I cannot accept this from galway county Council.

Fourthly to add to this debacle shambles unthought out proper plan. They are planning to elevate the motorway in my area if this is true in there design i am losing my scenic view of my surrounding area i live in. To add more trouble on top of me i am going to be affected after this road starts constructing to suffer the devaluation of my property putting me at a loss in negative equity. How does this motorway help me in any way with the value of my Home it dosent. How does the county Council of galway see fit to make rules different for one group of people but for others they can railroad right through and make matters worse from them rules to hurt peoples property in other areas i feel so let down by my local county councilers. It is so frustrating this system.

My Fifth major concern to me is my right of way / access to and from the road; i use to get to the main road that i use to go to my local village barna, also use to travel to get to galway city. If this N6 Motorway gets the go ahead my access to my usual route i use will be closed off to me once the construction phase starts not to mention i use this road route i currently use on a daily basis. My family members and friends also use this route and surrounding neighbours also use this route frequently. Now does that help us out by taking our main route away from us. We are not even near the city where we are located and all this trouble is being brought to our doorstep where there is no traffic problem.

My Sixth and last major concern is to me and my family safety and security is being threatened with the introduction of a crime element being brought to our area / region. I and my family firmly believe that once this motorway is built and completed there will be nothing to stop criminal gangs all over Ireland to hop in a transit van down this new motorway to come to our area and start committing burglary with the intent to carry out theft on not just our property but also surrounding properties in the area and along this whole proposed N6 bypass a lot of families will be exposed to a dangerous new possibility of our personal belongings and possessions being stolen and sold on the black market and also our lives may be in danger if a criminal breaks an entering while you are at home present. This scenario will become reality for many people along the bypass N6. The way current routes

My last concern with the proposed Motorway being
built through my area is because of the threat of a
C.P.O put on my residence. I have provided maps
to show you where they intend to C.P.O and show you
how we feel boxed in by them trying to C.P.O surrounding
lands to the back of property and not only C.P.O our
front entrance that we use to access our main route to
get to and from. On the maps you will see on one of
the A3 maps included the area shaded in grey they
wish land to be compulsory acquired galway county council.
If this C.P.O goes through i will be landlocked on
my land i will not be able to go for planning permission,
to develop and renovate or upgrade my current existing
property in the future. I wish to highlight as well if i
wish to sell my property i will not be able to do so
because with a C.P.O on my property the law of the
land forbids anyone in doing so. Once a C.P.O has gone
through and been accepted by law i may be landlocked
for years to come with no prospect of been able to move
left or right with regards that i wish to make decisions on
the future of my property that prospect is a very bleak one.
This trouble we never asked for this and i never voted
for this. This is brought on top of our heads by galway county council.
Also i would like to point out to include with the insult of

A C.P.O put on my property, we as citizens in our own area be looking at ~~the other prospect~~ that this motorway may never be built but i still as the landowner will be still in a landlocked situation because thanks to galway county council for putting it there in the first place. This leaves me and my family scared and vulnerable and in a dangerous place as regards to having no say no assurance or security in the future to my own premises this situation is all wrong.

Everything that i have stated in my Seven major concerns above are all listed in this letter of submission. These are the main issues that are affecting me and my family as regard to this N6 bypass motorway. I feel personally and strongly of the view that Galway County Council and city council do not take our concerns seriously or appropriately. When we liaised with them in our consultations with them as in regards to how this road affects me and my family we felt our input and concerns were of no concern to them whatever. We felt an atmosphere more of contempt if anything else when dealing with galway county council.

Galway City and County Council think that this is the best alternative to galway's transportation problems, but if you look closely at it, this is the very fact of galway city council and county council that all they have achieved with its ambition to rectify the transport problem, they have made a hames worth of the issue. This problem has been made worse with galway county and city council letting Property land

land developers build low density residential development on the outskirts of suburban galway city, with little or no thought on the poor quality of transport infrastructure in place which only made galway city's traffic problems worse.

Now with this new plan they have armed themselves with there is going to be far worse implications for galway city's traffic problems in the future it will increase 10 fold maybe even fifty or hundred fold. They say it will reduce traffic congestion unfortunately that is incorrect. By the end of the creation of this motorway being complete all it will do is let land developers get access to land banks that they wish to get to. We are already seeing evidence of this behaviour in my own townland country region where land developers are already starting to plan to build residential estates where the motorway is going through. Without properly looking where they are going they will only bring more chaos to galways traffic problem. It is also a terrible state of affairs when 44 homes are to be knocked and 10 more potentially to be added with people left in the dark as to who they are. I could be one of these potential people a frightening thought, hate to think of.

Knock na Carrs and Silverstrand within galway city itself in the morning when people go to work and afternoons from school and evenings from work. By going this far out to west Barna with this motorway all i see is Galway county council and city council only favouring land property developers. Instead Galway city and county council should be putting there efforts in making planners think better for the next 100 years of planning to change galway city in to a green eco city and reduce our dependency on cars and fossil fuels and make better use of new green technologies for better transport for public uses. We could learn a lot and have our planners and engineers look at other cities in the world. By doing this Galway city and county council would benefit greatly by doing this not only for its people but its future people as well if they get of course the right people for the job to plan better, a greener, Safer city than the one galway city and county council are favouring at this moment in time. This current option only really favours rich wealthy small visionary land developers. The cost of our future and our children's future is too high a price to pay.


