Dear Sir/Madam,

The attached signatories to this letter are residents of a small and secluded residential development known as 'The Heath'. Our properties are directly affected by the proposed CPO acquisition of Lands identified as 511a.201, as well as the associated right of way which it is proposed to be extinguished. As such, we feel obliged to make a submission to 'An Bord Pleanala'. Our concerns are summarised under a number of headings outlined below:

- Purpose of proposed Compulsory Purchase not explained in the documentation.
- We are strongly opposed to the proposed Compulsory Purchase of Green verges
- Real concern and disquiet that the Estate road if CPO'd, would be used during the
 Construction Phase of the Ring Road to facilitate machinery and other traffic
 associated with the construction project. The roadways are not suitable for such
 traffic and, if facilitated, represents a real threat to the residents of 'The Heath'.
- There are no assurances given as to the 'How' noise will be mitigated during the construction phase and, in the longer term, when the road becomes operational.
- While we have not been advised as to the reason for the CPO, it is rumoured that it
 is to give a right of way to a farmer whose property has been divided by the
 proposed N6. We understand that the portion of land to which the farmer does not
 have access, is miniscule. The logical solution would be to compensate the farmer by
 making an appropriate monetary payment. There are many precedents for such
 payments.
