I hereby wish to express Ibec's support for the N6 Galway City Ring Road planning application.

Ibec is Ireland's largest lobby group, representing Irish business both domestically and internationally. We work with government and policymakers to shape business conditions and drive economic growth. To this end, Ibec launched a major campaign this year, 'Better Lives Better Business,' whose aim is to make Ireland a better place to live and work. The delivery of critical infrastructure is a key pillar of the campaign.

Ibec is a national organisation with a very strong regional structure. The Ibec West Regional Executive Committee (REC) comprises of senior leaders from businesses in the region. Members are from a broad range of sectors including tourism, food, other indigenous industries and leading FDI companies. The Ibec West Regional Executive Committee (REC) is the representative voice of the wider West business community - small and large, indigenous and multinational.

The importance of upgrading the GCRR to the development of the West region has been previously highlighted in submissions by Ibec and the Ibec West Regional Executive Committee (REC), including to the National Planning Framework (NPF), the National Development Plan (NDP) and most recently in response to the Regional Spatial and Economic Strategy (RSES) Issues Paper for the Northern and Western Regional Assembly area.

The West is a strong performing region for foreign direct investment and is home to a significant lifescience cluster. Existing companies within the region, offer additional significant cluster opportunities and capacity for growth. However, inadequate road infrastructure risks undermining the region's liveability and hence the ability of the region to attract and retain staff and compete for investment. Commuting and accessibility impact considerably on quality of life.

Increasingly, it is the location of talent that attracts investment. Businesses locate close to talent rather than the other way around. To sustain economic growth and ensure that it can be better shared across the country, the region must offer strong quality of life and employment opportunities.

Substandard transport infrastructure has led to longer commutes and a chronically congested road network. Global traffic scorecards highlight the congestion challenge facing Metropolitan Galway. At peak times, a quarter of time spent driving in Galway is spent in congestion. Drivers in Galway are spending 44 hours per year in traffic congestion, equivalent to an entire working week. Galway performs worse for time spent in congestion than any other metropolitan area in Ireland and far larger European cities such as Rome, Madrid, and Brussels.¹ With a growing population and workforce, the traffic situation in the city will deteriorate without application of road space in the city to more sustainable, more efficient modes of transport such as walking, cycling, and public transport.

Traffic congestion is a significant challenge at strategically important sites in Galway and is proving a huge source of frustration for commuters. The severe traffic issues are having a direction expansion, business productivity, the quality of life of employees and ability of companies to attract and retain talent.

Companies are currently left with no alternative but to look to initiatives to assist employees with the traffic situation, such as changes to hours, causing disruption to normal work planning. Recruiting talent is challenging as the reputation around traffic can often be a negative. Future employees look at companies as more than just jobs and their work/life balance, commitment to the environment and wellness are all factors in the recruitment process. The GCRR scheme will provide direct access to major employment centres at Parkmore and Ballybrit Business Parks.

The N6 GCRR is included in Government's National Development Plan (NDP) 2018-2027. The scheme will give effect to the overall economic and social aims of the National Planning Framework (NPF) - Project Ireland 2040 and support its implementation. It will support more balanced growth across the country in line with national Government policy. It will also facilitate the effective implementation of the Galway Transport Strategy (GTS) which realises Galway City and County
