

While I fully appreciate the need for the bypass in Galway, the traffic is horrendous on the Parkmore road outside my house for 6.00am in the morning to nearly 7.00pm Monday to Friday. The N6 build significantly nearer to my property than I originally thought. There are 5 separate simultaneous projects running, the nearest of which is 42 metres from my property as shown in the photo above

#### **DUST**


I have had 3 rounds of sinus surgery in 2012,2014,2018 for the removal of polyps. I can provide consultants reports to verify this.

Dust is serious concern to me. I do not wish it on my property, garden or house as it affects my condition greatly. The house as per pictures above is situated in the epicentre of the construction.

I have read the links to construction plans which include covering of trucks for prevention of migration of dust, water sprinkling system to contain the dust, however given the property location it will be virtually impossible to contain all this dust.

#### Traffic

The traffic is already horrendous with currently only a left and right exit out of the industrial estate, how is the traffic from the construction going to be managed, if diversions are put in place. There are days here where the whole road can become gridlocked and Parkmore road impassable. I cannot get in or out of my house, my elderly parents are next door and long diversions are not an option for them

Arup have confirmed there will be blasting. What occurs if there are damages to my property from blasting, I would like an engineer report on my property to confirm its current condition and any damage that occurred during works is this provide, or do I need to get an independent one for this
