I strongly object to the manor in which the NTA has conducted itself in the planning and implementation of the Core Bus Corridor Blanchardstown to City Centre route 5 particularly in relation to Navan Road.

- Lack of consultation, in that we received 1 phone call from an engineer representing the NTA in 2 years.
 - a) Even with the ending of COVID restrictions on public gathering's the NTA has refused to meet with the residents of Navan Road and adjoining estates to listen to residents concerns regarding the removal of mature trees, the closure of roads and the compulsory purchases of private gardens including 1.3 Metres of our front garden.
 - b) The deadline for submission of objections in the middle of the holiday season were a lot of residents and public representatives are still on leave is extremely cynical and shows a total lack of respect for the effected communities.
- 2) Noise and vibration. (Environmental impact assessment report).
 - a) Traffic noise levels for Dublin City suggest that below 55 db. is desirable by day and below 45 db. at night.
 - b) Table 9.20 Chapter 9 states that traffic noise levels taken at Owl
 Cottage, Navan Road/Nepean Road junction comes in at 70 74 db.
 by day and 55 -59 db. at night. Undesirable high on both readings.

c) With the planned widening of the Navan Road and busses travelling much closer to residential properties this noise/vibration will only get worse.

3) Compulsory Purchase Order.

- a) We were served with a CPO on 29th June 2022 with the loss of 13.7^m
 ² (1.3 metre in depth) permanently and a loss of 21.7 m² temporarily.
 This loss will lead to a permanent loss of property value.
- b) This loss will make it more difficult to turn around therefore making entering and exiting much more difficult to do safely.
- c) This land take will **not** result in segregated cycle lanes on either side of the Navan Road with bus passengers getting on and off straight from a foot path blocking the cycle lane, so what is the whole point?

4) Trees.

- a) The loss of so many mature trees, (Approx 150) most of which were planted over 40 years ago is environmental sabotage as they are visually appealing, help cut down on traffic noise and of course help with the reduction of carbon emissions.
- b) Turning the Navan Road from a tree lined avenue into a concrete road so a bus will arrive on Arron Quey 10 minutes quicker serves no purpose.

5) Reversible Bus Lanes.

- a) A continuous city bound bus lane has been in operation from the Blanchardstown shopping centre to Cabra Cross junction for some years.
- b) Para 5.4.2.2 of the **Draft Preferred Route Option** states "An alternative approach of operating bus lanes in one direction only for short sections has been assessed to ascertain whether land take requirements could be reduced". These types of bus lanes are used

across most modern cities to facilitate city bound traffic in the morning rush hours and vice versa in the evening when returning home. Unfortunately, the result of this assessment is not mentioned in the report!

Summary of concerns.

- Compulsory Purchase of front garden without looking at viable options as was done for other Core Bus Corridors.
- · Lack of consultation.
- Destruction of many mature trees along the Navan Road.
- Vibration, noise, and frequency of buses closer to private properties.
- Closure of Old Cabra Road will lead to excessive traffic on the already congested Cabra Road and other local roads, namely Baggot Road, Nephin Road, Screen Road and Blackhorse Avenue.
