- 5. Please describe the grounds of your observation (planning reasons and arguments). You can type or write them in the space below or you can attach them separately.
 - 1. It is planned to destroy over 100 mature trees along the Navan Road. These trees provide shelter and noise reduction to the neighbourhood and they are part and parcel of the local environment. The trees clear the local atmosphere and they absorb huge amounts of Co2. If these trees are felled the saplings planted instead of them will leave the neighbourhood naked and it will be 35 years before the new trees will absorb a similar amount of Co2.
 - 2. It is planned to remove the roundabout at the Halfway House and replace it with a box junction. The roundabout and the mature trees on it is essentially the entrance into the residential neighbourhoods of the Navan Road and Castleknock. The Navan Road is not a motorway, it is a residential neighbourhood. It appears to me that the removal of the roundabout and its lovely trees represents a retrograde step in the planning process and it will seriously disimprove the neighbourhood.
