

## LIFFEY VALLEY TO CITY CENTRE CORE BUS CORRIDOR SCHEME

The National Transport Authority (NTA) has applied under section 51(2) of the Roads Act 1993 (as amended) to An Bord Pleanála ('the Board') for approval in relation to a proposed road development consisting of:

The construction of the Liffey Valley to City Centre Core Bus Corridor Scheme which has an overall length of approximately 9.2km and is routed along the Fonthill Road, Coldcut Road, Ballyfermot Road, Sarsfield Road, Memorial Road, Inchicore Road, Grattan Crescent, Emmet Road, Old Kilmainham, Mount Brown, James's Street, Thomas Street and High Street, all in the County of Dublin and within the South Dublin County Council (SDCC) and Dublin City Council (DCC) administrative areas, comprising inter alia:

- 9.2km (two-way) of bus priority infrastructure and traffic management;
  - 13.3km (total both directions) of cycling infrastructure and facilities;
  - Provision of new/refurbished pedestrian facilities and footpaths along the scheme and associated ancillary works;
  - Provision of 27 junction upgrades including conversion of three existing large roundabouts to signalised junctions and associated ancillary works;
  - Provision of 69 new/refurbished raised table side entry facilities;
  - Reconfiguration of existing bus stops resulting in 52 number new bus stop facilities;
  - Public Realm works including landscaping, planting, street furniture, street lighting, retaining walls, boundary walls and sustainable urban drainage (SUDs) measures;
  - Roads associated earthworks including excavation of unacceptable material, importation of material, temporary storage of materials;
  - Provision of road pavement, signing, lining and ancillary works;
  - Provision of gates, fencing and boundary treatment works;
  - Provision of new and diverted drainage infrastructure;
  - Diversion of utilities and services including associated ancillary works; and
  - Construction of accommodation works including boundary treatment and ancillary grading and landscaping works;
- together with all ancillary and consequential works associated therewith.

The location of the proposed road development is illustrated in the accompanying map. The NTA has submitted to the Board the Environmental Impact Assessment Report prepared in accordance with Section 50 of the Roads Act 1993 (as amended) and Directive 2011/92/EU of the European Parliament and of the Council of 13 December 2011 on the assessment of the effects of certain public and private projects on the environment as amended by Directive 2014/52/EU of the European Parliament and of the Council of 16 April 2014 in respect of the proposed road development.

A Natura Impact Statement has also been prepared and has been submitted to the Board in respect of the proposed road development under Part XAB of the Planning and Development Act 2000 (as amended).

- the likely effects on the environment of the proposed road development, if carried out;
- the implications of the proposed road development, if carried out, for proper planning and sustainable development in the area in which it is proposed to situate the proposed road development; and
- the likely significant effects of the proposed road development on a European site

between Tuesday 19<sup>th</sup> July and Tuesday 13<sup>th</sup> September 2022.

Any submissions/observations must be accompanied by a fee of €50 and must be received by the Board not later than 5.30 p.m. on the 13<sup>th</sup> September 2022. This fee will not apply to certain prescribed bodies including those specified in section 51(3)(b) of the Roads Act 1993 (as amended) or to landowners and others with a legal interest in land who are objecting to compulsory acquisition of land in which they have such an interest in a compulsory acquisition case.



Údarófar don Údarás leis an ordú na cearta slí poiblí a thuairiscítear i gCuid III (Roinn A) den Sceideal a ghabhann leis seo a mhúchadh trí ordú arna dhéanamh aige tar éis dó an talamh a fháil, i gcás go mbeidh na cearta slí poiblí thar an talamh arna fháil amhlaidh nó thar aon chuid den talamh sin, nó thar talamh atá tadhlaich leis an talamh sin arna fháil amhlaidh nó le haon chuid den talamh sin nó a bhaineann leis an gcéanna.

Údarófar don Údarás leis an ordú na cearta slí poiblí a thuairiscítear i gCuid III (Roinn B) den Sceideal a shrianadh, nó cur isteach orthu ar shláile.

The National Transport Authority (hereinafter referred to as the "NTA") in exercise of the powers conferred upon them by Section 76 of the Housing Act, 1966 , and the Third Schedule thereto, as extended by Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Roads Act, 1993 and as amended by the Planning and Development Act, 2000 (as amended), Section 184 of the Local Government Act 2001 and Section 44 of the Dublin Transport Authority Act 2008 (as amended), have made an order entitled as above which is about to be submitted to An Bord Pleanála for confirmation.

If confirmed, the order will authorise the NTA to acquire compulsorily the land and/or rights described in Part I, Part II and Part IV (Section A) of the Schedule hereto for the purposes of construction of the Liffey Valley to City Centre Core Bus Corridor Scheme for the purposes of facilitating public transport, and together with all ancillary and consequential works associated therewith. The scheme has an overall length of approximately 9.2km and is routed along the Fonthill Road, Coldcut Road, Ballyfermot Road, Sarsfield Road, Memorial Road, Inchicore Road, Grattan Crescent, Emmet Road, Old Kilmainham, Mount Brown, James's Street, Thomas Street and High Street, all in the County of Dublin and within the South Dublin County Council (SDCC) and Dublin City Council (DCC) administrative areas.

Owners, lessees and occupiers of the land and/or rights described in Part I, Part II and Part IV of the Schedule will receive individual written notice.
