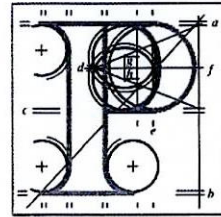

We wish to respond to the submission dated 15 May 2023 received by ABP from the National Transport Authority.

Having read through the very detailed document we note that 66 out of the 81 submissions received by ABP regarding this scheme were concerned solely with the Palmerstown section of the scheme – another 4 also referred to the Palmerstown section as well as other matters. This should send a very clear message to An Bord Pleanála and to the NTA that there is great concern in Palmerstown regarding the effect the proposals in this scheme will have on the everyday lived experience of people in this community.

The NTA Response document lists and categorises all the points included in the above 81 submissions and replies to them quoting various reports, guidelines etc e.g. re removal of left-turn slip lanes “DMURS states ‘Omit left turn slips, which generally provide little extra effective vehicular capacity but are highly disruptive for pedestrians and cyclists.’” This is certainly not true for traffic exiting left from Kennelsfort Road Upper onto the R148 towards the M50; or for traffic exiting left from the Oval onto the R148. The NTA Response dismisses most of the other concerns raised in a similar general manner- instead of looking carefully at the particular points raised.

Many of the issues raised by residents arise as a result of the 26/80 bus being routed through Palmerstown Village and the removal of the 18 bus route – and although the NTA state that the ‘provision or removal of bus services, as well as the routes is not part of the scope of the Proposed Scheme planning application’ – we would appeal to An Bord Pleanála to take this issue into account as it obviously is material to the infrastructure being proposed.

We would also urge An Bord Pleanála not to take the NTA Response at face value but to take on board the concerns of the people who actually live in this area and to forensically examine the issues we have raised in our 66 submissions.
