

I refer to your correspondence dated 06 June 2023, which refers to the submission dated 15 May 2023 from the National Transport Authority concerning the responses to the submissions from interested parties, including yours truly, on the BusConnects Lucan to City Company proposals.

The NTA response is an extremely comprehensive document listing all the submissions individually, including that of yours truly.

However, given that about three quarters of the submissions to the BusConnects proposals were from Palmerstown, it should be readily apparent to both ANP and NTA that the residents of Palmerstown are extremely concerned about, and opposed to, most of the BusConnects proposals.

Our main concerns are that the NTA responses show a lack of appreciation of the impact on Palmerstown and its residents, and are in fact, rather dismissive of the most of the various issues highlighted by the Palmerstown submissions.

Our group's particular concerns are the proposals to remove of the slip lanes from Kennelsfort Road Upper and The Oval, together with the proposals to route the 26 buses through Palmerstown Village.

We feel that these proposals are a sweeping approach to traffic in Palmerstown, and are not based on any in-depth analysis of the traffic levels. We further feel that they are unnecessary, and will in fact be counterproductive to the resolution of traffic congestion.

Therefore, we request that ABP does not support the NTA responses, but rather agree to a more in-depth analysis of the concerns of the residents of Palmerstown, given the level of the our responses to the BusConnects proposals.
