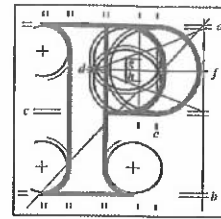

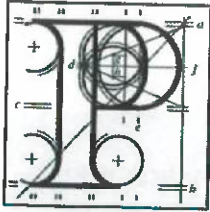

I object to the proposal to the Pedestrian crossing moving from Applegreen to behind Shaws (From East to West junction) and the removal of the left turn filter from the Oval unto the dual carriage way.

Due to the unprecedented volume of traffic causing large traffic jams on the Kennelsfort Road during peak times, a lot of traffic is forced to use the roads leading pass the Oval and out unto the bypass during early morning and evenings. Combined with the School runs due to the school's location on the Oval, the filter to the left heading towards Lucan is paramount to help alleviate help the bottle neck cause by during these times.

The moving of the pedestrian crossing to the suggested location will cause a serious backup of traffic using that exit causing a serious bottleneck resulting in most roads being blocked in the estate between 7am and 9am. There is a large amount of pedestrian traffic using the crossing at that time catching buses, children going to school in the Oval, access to the Palmerstown village, Stewarts, Waterstown and the walkway to Chapelizord/Ballyfermot during the early morning and evening is quite considerable. What happens then when the Oval and other roads are blocked with people trying to use that exit, drivers that are not using the exit overtake on the wrong side of the road to try use the roads from the Oval to

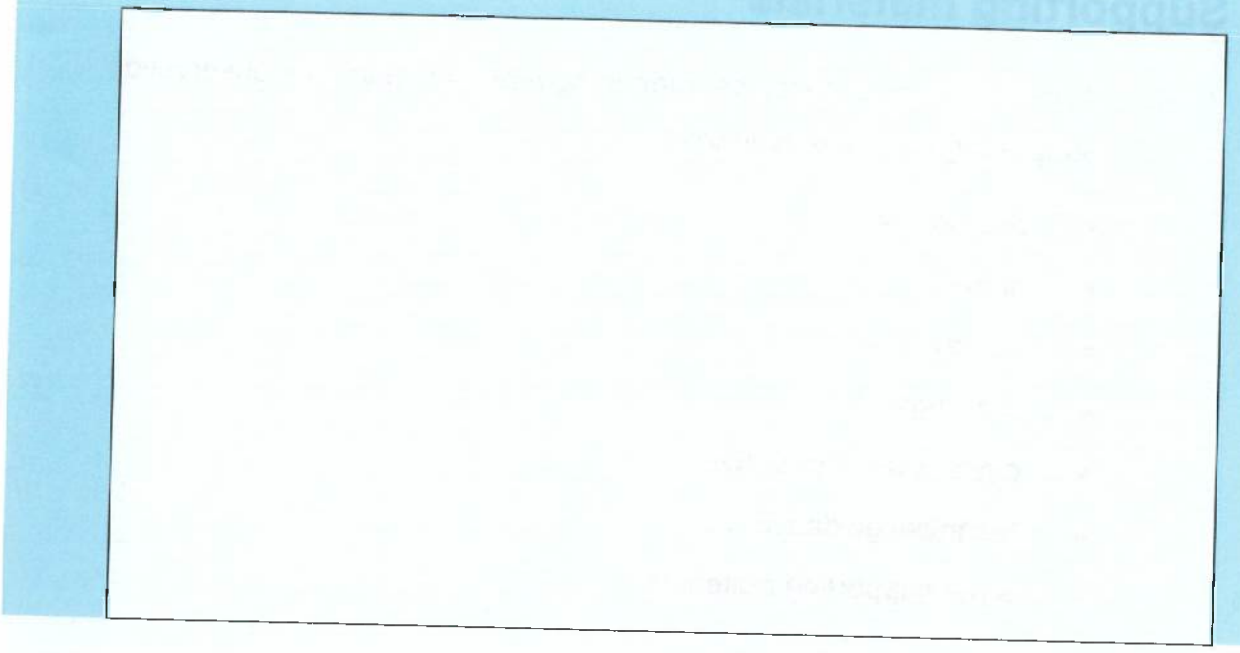

Turret Road. It becomes dangerous especially with traffic coming into the estate from dual carriage way as they do not see the cars and are coming at some speed. I feel that this will cause serious issues especially if an ambulance is required as there is many elderly persons living in the estate. Many will feel they are a prisoner in their own home during those hours as a result of this change.

I also reject the loss of parking spaces in the Village, the traffic is already extremely busy and a severe shortage of parking for the shops, church and the community centre. When the apartments are occupied, this traffic will increase dramatically. With the removal of all northside parking, there is no facility for off street public parking for people using the village nor is there one proposed. This will cause a serious impact on the Village as it will be losing the community feel that the village should have and what small businesses will close as they are struggling as it is. Small businesses should be encouraged in the village as they provide a vital service to local residents.

There has been a great improvement in the bus routes and cycle lanes but not at the cost of destroying the village community and the small businesses. It is my hope that these two issues can be addressed as the Village was divided by the carriage way already leaving the village struggling to keep it identity – this will only make it worse by taking the available parking away and offering no provision for off-street public parking. COVID has made us very aware that communities and local amenities are extremely important and should be encouraged at all costs. Remembering the 2km restrictions.
