

RE: NRA Lucan to City Centre Bus Corridor Scheme.

We would like to submit an observation regarding the above proposed Scheme, as Residents of the Area, and the impact it will have on the people of Palmerstown Village and Estate.

- Rerouting the 26 bus or (soon to be the 80 bus) through the Village is a complete waste of time and money, and no residents are in favour of it. Most of the proposed changes in Palmerstown Village surround this move.
- As it is proposed to remove the left turn from the Village into town at the Kennelsfort Road Exit, all Traffic exiting the Village will have to Exit at the Applegreen which will cause major tail backs through the Village and this is totally unnecessary.
- The removal of the Bus stop at the Drive makes no sense as this services The Drive, Culmore Road, Glenaulin Road and there are a lot of elderly people that would have to walk a lot further and cross at the very busy Oval Junction.
- Removing the left Filter light at the Oval Exit will cause a dangerous level of Traffic and will be a Safety Hazzard for Children trying to cross from the boys and girls Schools at the Oval.
- Basically The NRA do not realise the impact and Safety issues that would be caused to the residents of Palmerstown by running the 26 Bus through the Village for 1 Stop, and this is our only chance by submitting our Oberservations to you An Bord Pleanala to have our concerns heard. So we would appeal to you to look into it more seriously before making your decision on this matter.
