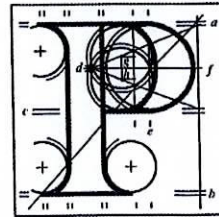

To whom it may concern:

I would like to submit the following observations in relation to the above.

Public Health/air pollution

The high levels of polluted dust from the site will not only affect the public area but also the private dwellings. If this site continues to be used and expanded the impact on the pulmonary function of the neighborhood will be exacerbated even further with the population of elderly and young being most affected. There are known cases of asthma and COPD sufferers in the area requiring oxygen.

The airborne particles from the dust—thirty times smaller than the width of human hair—can pass easily into the lungs and bloodstream, where they can increase a person's risk of dying from heart disease, stroke, lung cancer, chronic obstructive pulmonary disease, and lower respiratory infections

I believe the proposed construction compound should not be granted permission due to the potential for continuous and increased health issues and risks.
