

We wish to object to the above planning application, particularly the effect of proposed traffic changes on us as residents of Rathdown Villas, Terenure.

We fully support the observations in the letter of objection submitted by Senator Mary Seery Kearney (SID-OBS-001035) on behalf of 115 signatories, and we wish to make the following further observations.

Ban on Right Turns

As residents of Rathdown Villas, off Rathdown Park, we are very concerned that the proposal focuses on transport through Templeogue and Terenure for those who do not live or work here, and completely ignores the effects that the changes will have on residents. It prioritises speed of travel through the villages at the expense of daily disruptions for residents.

The Rathdown estate consists of Rathdown Park, Rathdown Avenue, Rathdown Crescent, Rathdown Drive and Rathdown Villas. There are just three vehicle entrances/exits from the estate – two on Templeogue Road and one on Rathfarnham Road.

The proposed bans on right turn off Templeogue Road into Rathdown Avenue and into Rathdown Park would have serious consequences for residents of the Rathdown estate and contribute almost nothing to the overall objectives of the proposal. The consequences for residents are not discussed or acknowledged in the proposal.


Diverting local traffic

The proposed right turn bans from Templeogue Road would mean that residents of Rathdown coming home from south or west would have to divert right onto the R112 and all the way around back to Terenure. This means that instead of travelling the short distance from Templeville Road to a

right turn into the Rathdown Estate, residents would have to join the traffic on a long loop around Bushy Park and the Rathdown estate via the R112 and the R114 (Rathfarnham Road) to the other side of the Rathdown estate.

In addition, the two existing right turn bans in the centre of Terenure for traffic coming from KCR direction (onto Templeogue Road and onto Rathfarnham Road) mean that at the moment traffic coming from Walkinstown, Kimmage, or Sundrive to Rathdown must divert from the KCR to Fortfield and Templeogue Road, and then turn right into Rathdown Avenue or Rathdown Park. That existing situation will be exacerbated by the proposed new right turn bans. Traffic coming from those directions will have to continue on the R112 and R114 to the other side of the Rathdown estate.

The result is that any residents coming home to the Rathdown estate from the direction of the M50, Templeogue, Walkinstown or Sundrive will have to travel around in a loop to get to the other side. See the marked up map below.



Green is the existing route via Templeville Road junction to our homes in Rathdown Villas. Red is the route we would have to take if the proposed right turn bans are implemented.

Most of the car journeys affected by this right turn ban cannot be replaced by bus journeys because the proposed bus routes only serve a narrow corridor to Terenure along the R137 from Tallaght and the M50. Examples of car journeys to the Rathdown estate that cannot reasonably be made by bus and that will be made longer by the changes include:

- Returning home via the M50. In effect, this includes any journey from outside Dublin.
- Journeys home from doctors or pharmacies in the Templeogue or Kimmage areas.
- Travelling home from the An Post sorting office in Fortfield, which serves the Rathdown estate. It is frequently required to collect undelivered parcels from the sorting office.
- Travelling home after using petrol stations in Templeogue, Fortfield or KCR.
- Travelling home after using or attending sports facilities in Templeogue, Spawell, Templeville Road, or Dolphins Barn.
- Returning from visits to Crumlin Hospital (there is a large number of families with young children in the Rathdown estate).
- Returning home after visits to the Phoenix Park or Dublin Zoo.

 One very specific but very important example is older people attending religious services in Terenure College. Although the distance is easily walkable by most people, those who must go by car will now have to return home by going outwards on the Templeogue Road and all the way around Bushy Park and the Rathdown estate to return home.

In effect, the right turn bans will reduce the ability of Rathdown estate residents to use facilities in Templeogue and Kimmage, and will reduce interaction between those communities.

Shifting local traffic from the Templeogue Road onto the R112 and the Rathfarnham Road like this will not contribute to the overall objectives of the proposal. Instead, it will increase traffic in the area by diverting it onto a longer and already congested route – the R114 (Rathfarnham Road).

No Rationale

There is no reasonable rationale for the two right turn bans from Templeogue Road onto Rathdown Avenue and onto Rathdown Park. It appears that the bans may be intended to prevent rat running, although there is no specific reason for these right turn bans given in the proposal. There are three arguments against the rat running rationale.

- Rat running through Rathdown Park occurs at the moment during peak morning traffic, and
 is no more than an irritation to residents. It is controlled to some extent by the restricted
 green period on the traffic lights at the exit to Rathfarnham Road. It is not a major problem
 for residents.
- Rat running from Templeogue Road to Rathfarnham Road through Rathdown Park does not, and will not, affect the operation of the bus corridors.
- Preventing rat running by banning right turns from Templeogue Road imposes much more of an inconvenience on residents than any rat running does. Traffic engineers are fixing a small problem by creating a big one.

Conclusion

In general, the proposal takes no account whatsoever of residents travelling to and from their homes. The proposal seems to consider that preventing rat running and providing *quiet street treatment* is sufficient for local residents. It gives no consideration at all to how residents travel to and from their homes, particularly when returning home from outside Dublin City.

The two right turn bans from Templeogue Road into Rathdown Avenue and into Rathdown Park should be omitted from the plan, or at the very least should be limited to peak morning traffic hours.
