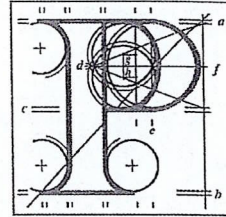



Rathfarnham/Temploeque Bus Corridor

To whom it may concern

As a Councillor of the Rathfarnham/Temploeque Area, I wish to support Rathfarnham Wood Residents Association and Beaufort Downs Residents Association on their submissions on 2 issues requiring to be looked at regarding BusConnects from Rathfarnham Road R114 to R115/R821 junction.

- 1) The number of trees to be taken out for such a short section and the granite wall opposite St. Mary's Boys School.
- 2) The number of bats and their rooks been removed plus the natural habitat of so many other animals and ducks to be lost out on, in their natural woodlands and area of significance to the people of DSW, who walk and live beside Rathfarnham Castle Park.

In support of Woodview Cottages Residents Association, Church Lane, my submission raises the point of moving the BusConnects Depot from the R112 Dodder View Rd to a more suitable location in the area thus not disturbing the significant Historical knowledge it holds. The serious dust falling on residents continuously for years while Construction takes place, with Asthma and Pulmonary conditions, is by no means desirable.

I give overall support to increase the public transport within the Temploeque/Rathfarnham Area along with Recorder Residents Association, but in their submission amongst numerous issues, BusConects gives a severe rise of concern for the DSW area going forward, with no Metro.

I wish to support the many submissions made by Residents Groups and individuals on this point and hope that an Bord Pleanála will look favorably on their position.
