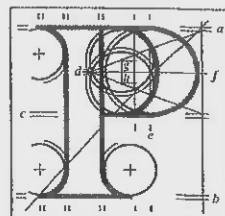


Please note that the proposed road development shall not be carried out unless the Board has approved it or approved it with modifications.

**Comments on Application for Templeogue Rathfarnham Bus Corridor Ref. 316272**

This is an observation on behalf of the undersigned residents of Greenlea Road regarding the Right Turn Ban from Fortfield Road to Greenlea Road.

We support the right turn ban as we believe that the traffic being redirected as a result of the closing of city bound traffic on Templeogue Road between Fortfield Road and Terenure Village would result in a huge increase on traffic on our road especially during morning rush hours. This increase in traffic would be detrimental to the suburban character of the road, would cause significant noise and air pollution. It would also give rise to an increased danger to the children and elderly crossing the road because of the extensive parking along the road on both sides.

We are concerned that the Terenure West Residents Association is making an objection to the Bus Corridor Application that includes in their grounds that residents of Greenlea Road would not be happy with the Right Turn Ban on account of the inconvenience to them. We believe that the positive impacts of the proposed ban far outweigh the relatively minor inconvenience of a small detour.
