



Whilst I support the overall aims of the proposed development (efficient, safe and integrated sustainable transport movement), the scheme as proposed will not deliver sufficient benefit for what it involves, will cause real difficulty for our community (and others along the route), especially for traffic surrounding the corridor.

A particular issue is the greatly increased levels of vehicle traffic which will be generated on Highfield Road, by virtue of Rathgar Road becoming one-way for private vehicle traffic, in the direction in town. As a result of that (and of the proposal to permit the right turn for vehicles from Rathmines Road Upper to Highfield Road), Highfield Road will become the main route out from town for motor vehicle traffic travelling out of town in the direction of the corridor.

This is not sustainable. Highfield Road will not be able to accommodate that level of increased traffic. As it is, there is ongoing traffic congestion on the road, with traffic jams at the Rathgar end across a lot of the day. Between the increased traffic volume and the proposal to allow right turns from Highfield Road to Rathgar Road (not currently permitted), this will only increase the problem. I believe it is also intended that there will be bus traffic on Highfield Road in future, which again will amplify the problem.

5. Grounds

This will not be safe for any road users or pedestrians nor will it be sustainable or efficient (the aims of the proposed development). It will also greatly damage the amenity of the neighbourhood.

The benefits which are stated as achievable from this development are not proportionately worth the investment or the disruption. Trees and gardens along the route will be lost, the commute time savings are relatively small, and it appears the expected increase in bus users will be relatively small.

I believe that alternatives should be pursued to more meaningfully reduce reliance on motor vehicles for commutes. This proposal will really just push vehicle traffic on to a different, smaller road network rather than meaningfully reduce traffic or deliver the aims of the proposed development.
